ONCE TRADITIONAL REHABILITATION IS COMPLETE AND/OR INSURANCE WILL NO LONGER COVER REHABILITATION SERVICES, OUR RECOVERY PROGRAM HELPS THOSE WHO WISH TO FURTHER THEIR RECOVERY POTENTIAL.
